# 5. Annual Accounts for the period 1/2/2019 to 31/1/2020

# 5.1 Presentation of Accounts

Lee Cramer presented the accounts.

#### 5.2 Accounts questions

Questions received in advance of the meeting:

Q: The Financial Statement lists a Director as "TH". To whom does this refer?

A: This is a typo referring to Tara Bowers and has been updated in the accounts.

Q: The Financial Statements state that ECOE has no employees, but a payment for Social Security of £3,294 is listed. To what does this relate?

A: The £3,294 relates to the VAT liability owed at the year end.

Q: The ECOE Loan Opportunity asks applicants to "...complete the loan agreement..". Is the Loan Opportunity the Agreement, or is there another Loan Agreement document that has not been presented to the AGM?

A: There is a separate agreement document. This will be shared with anyone expressing an interest after the AGM.

# 5.3 Voting to:

5.3.1 Approve the Directors' recommendation to pay share interest to members at the rate of 5% per annum for the 12 months ended 31 January 2020.

Approved In favour: 34 (including proxies). Abstentions: 1. Against: 0.

5.3.2 Approve the Accounts for the year ended 31 January 2020

Approved In favour: 31 (including proxies). Abstentions: 1. Against: 0.

5.3.3 Approve the Directors' recommendation to not require a full professional audit of the Accounts.

**Approved** In favour: 33 (including proxies). Abstentions: 4. Against: 0.

5.3.4 Approve the Directors' recommendation to allocate £3,500 from the profits of solar PV plus such other amounts as are decided by the directors to the Community Fund in financial year ending 31 January 2021.

Approved In favour: 35 (including proxies). Abstentions: 1. Against: 0.

# 6. Appointment of Directors

#### 7. Any other business

### 7.1 PV3 loan launch

Andy Extance explained the procedure for subscribing for the PV3 loan.

#### Questions

Q: How are shares redeeemed?

A: Members submit a request and repayment is made in 3 months, subject to Board approval

Q; Is ECOE admitting new members?

A: Not at the moment, but investment is now possible via the PV3 loan scheme.

Q: Is ECOE interested in district heating schemes?

A: Several local schemes are being considered by Exeter City Council but generally ECOE believes these are too large and complex for its involvement.

Q: What is ECOE's relationship with housing societies and housing associations?

A: We can provide advice around retrofitting but it is usually not possible for ECOE to get actively involved.

Q: Why is there a need for ECOE to have a Hardship Fund?

A: Although there are other sources of help for heating (eg fuel vouchers), there is a gap in provision for assistance with items such as broken appliances which people may not be able to afford to fix.

Q; Should ECOE be actively involved in passivhaus planning applications?

A: We are not currently involved as there is still a policy gap around residential standards for low carbon homes.

Q: What is the status on anaerobic digesters?

A: This is an area ECOE will consider if there proves to be a viable business case.

Q: Should ECOE campaign on the climate emergency?

A: ECOE 'walks the talk' on the climate emergency and, when possible, promotes awareness through public events.

Q: What is the advantage of ECOE investing in large scale solar PV over letting Devon Energy do it?

A: ECOE's involvement would provide an opportunity for investment for local people and also give us more of a voice in how profits are used to support the community.
